Since joining UNIDO in 2007, he has held key positions including Chief of Responsible Materials and Chemicals Management and Emerging Compliance Regime and led global programmes on resource efficiency and eco-industrial parks. Previously, he was Director of the Morocco National Cleaner Production Centre and worked at CNESTEN. He holds master's degrees in nuclear safety engineering as well as mechanical engineering.



Deliloglu Alpaslan is Country Manager & Chief Sustainability Officer at IKEA Austria. Before joining the Austrian team in 2019 he was Deputy Country Manager in Switzerland and Commercial Director in Turkey.
